Eligibility Criteria

- Bachelor's or master's degree or equivalent
- Some background in mathematics, ideally at basic calculus level or more

Not Required for Admissions but Considered an Advantage

- Previous education in economics or related fields, such as other social sciences, mathematics, statistics and various technical fields
- Standardized English test report (TOEFL, IELTS, etc.)
- Proficiency tests proving your readiness to study at graduate level, such as GRE, GMAT, or other
- Relevant work or internship experience

Documents Required

- Online application form
- Filled out motivation form
- Scans of all your diplomas and transcripts translated into English
- Scans of all your original diplomas and transcripts, in the original language
- Scan of the main page of your passport
- Contact details of two referees
- Optional: TOEFL, IELTS, or other certified English language exam score / GRE or other proficiency test score

Admission Process

After your application is complete, you will be invited for a phone or Skype interview. Please allow 60 minutes for your interview. The interview consists of two parts:

- Mathematics assignment (45 minutes)
- Interview (15 minutes)

Tuition

- 7,500 USD when you apply by 30 November
- 9,500 USD when you apply by 31 March
- We have a number of financing options to meet the financial needs of our students, including tuition discounts and fellowships. No full scholarships are granted; the minimum tuition level is 1,900 USD for Public Service Fellows.
